Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed <u>and</u> (2) the defendant is the one who committed it:

On Tuesday, May 7, 2024, the Township of Teaneck was conducting a Township Council meeting open to the public that occurred in the Township Council Chambers, located at 818 Teaneck Rd. During the meeting, at approximately 9:25 P.M., an individual later identified as Layla Graham disrupted the meeting several times by playing audible sounds at a high volume from her cellphone. Ms. Graham was advised by the Township Mayor and Township Manager, to silence her phone, which she refused. After approximately three warnings, she was then told to leave the meeting on behalf of the Township Mayor and Township Manager, who were in charge of the meeting. Ms. Graham refused to leave the meeting and the premise. The Township Mayor and Township Manager then conveyed the circumstances to Detectives W. Drinker #347 and Melissa Teprstra #365 who were assigned as security for the council meeting. Detectives spoke with Ms. Graham and advised her that she was no longer allowed in the Council Meeting or Township building, and would be arrested for defiant trespassing if she failed to leave. Ms. Graham had to be physically removed by Detectives. While physically removing Ms. Graham Ms. Graham did not get out of her chair, refused to stand or walk, and pulled away from Officers attempting to gain control of her. During this time, a co-defendant, Ms. Amanda Kearny, obstructed the officers by putting herself between the Detectives and Ms. Graham. Ms. Kearney also pulled Det. Terpstra away from Ms. Graham while she was attempting to gain control of her. The Township Mayor and Township Manager then advised Detectives that Ms. Kearney was also not allowed back in the Council Meeting or Township Building for disrupting the meeting. All individuals were then removed from the building and advised not to return or enter Town Hall. At approximately 9:58 P.M., both Ms. Graham and Ms. Kearney entered the main lobby for Teaneck Town Hall, and were both arrested for defiant trespass. During the arrest of Ms. Graham, she pulled her arms away from DSGT. James Lynch and also tensed her arms to prevent being placed under arrest. During a subsequent search of Ms. Graham's persons and property incident to arrest, Ms. Graham uttered a spontaneous utterance that she was in possession of a stun gun which was located in her backpack. DSGT. Lynch subsequently located a yellow stun gun in the outer compartment of her backpack.
